

Signing up to receive eStatements and eNotices on your SLFCU accounts eliminates the need for you to receive paper statements and notices. And, for every new eStatement/eNotice registration made now through December 31, 2020, SLFCU will donate \$1 to the National Forest Foundation – enough to plant a tree in the National Forest System. If all SLFCU members currently receiving paper statements changed to eStatements, we could plant nearly 80,000 trees!

Viewing your eStatements and eNotices

When you enroll in eStatements and eNotices, SLFCU will send you an email each month to let you know your statement is ready

to view or print securely through online banking. The statement itself is NOT emailed to you.

SLFCU will email notices – with personal information masked for your security – to alert you about account activities such as certificate renewals, CreditLine advances, loan add-ons, overdraft transfers, and insufficient funds.

Enrolling is easy

To enroll, log in to online or mobile banking and select the eDocuments widget. In most cases, enrollment is instant. However, you may receive any paper statement or notice that was generated before you enrolled.

Fall 2020 Real Estate Report: Albuquerque Area and Tri-Valley, CA

After a dip in residential selling activity over the first half of 2020 due to the COVID-19 pandemic, the market is rebounding nationally as economies open back up and mortgage interest rates fall to record lows.

Albuquerque: Homes are Moving Fast

COVID-19 restrictions made potential sellers hesitant to put their homes on the market, which greatly decreased inventory in the area, says HomeAdvantage® agent Valerie Almanzar of Your Casa Team. "That, combined with incredibly low interest rates, is contributing to a very fast-moving market," she notes, adding, "It will take time for the market to go back to 'normal' for the area. If conditions stay the same, we will continue to see a rise in home prices into 2021."

Valerie adds, "We are seeing buyers – including many first-timers – getting more home for their money because the low interest rates give them more buying power. On a month-by-month basis, the average number of days a home is on the market continues to decline, and it is really clear to sellers if a home is overpriced. We are seeing homes get multiple offers, and buyers are offering upfront to pay the difference if the home does not appraise at the selling price."

Her top advice is to work with an experienced agent and/or team. "There are a lot of people getting into real estate right now who do not necessarily know how to negotiate and protect their clients," she cautions.

California's Tri-Valley: On the Rebound

In the Tri-Valley area, the market has made a dramatic

recovery after steep year-over-year declines in March and April. Buyer demand soared in May and June, almost surpassing 2019 peak levels.

Claudia Colwell, a HomeAdvantage agent serving the Tri-Valley community at J. Rockcliff Realtors, expects prices to go up in 2021. She's also seeing more first-time buyers, perhaps due to people working remotely and planning to do so into the future. "There is a huge opportunity for young buyers to move out of the more expensive parts of the Bay Area and purchase instead of rent," she notes. "The number of properties sold has decreased due to low inventories, and median prices have risen by about 8% since 2019," she adds. Her top advice is to be patient and stay informed, as the market can be challenging and the process can feel overwhelming.

Accident Leads Teen to a Powerful Learning Opportunity



As SLFCU continues to raise funds for the New Mexico Credit Unions Connected Academy (NMCUCA¹), we'll periodically feature patients who have, or would have, benefited from having a teacher available at UNM Children's Hospital (UNMCH).

Meet Jesus, an energetic 15-year-old who is learning to cook and loves playing video games, football, and basketball. On October 23, 2019, after he played basketball at his neighborhood park and was walking home, Jesus was struck by a car. An ambulance transported him to UNMCH, where he underwent surgery to relieve trauma-induced pressure building around his brain.

While Jesus was recuperating in the hospital, he met Monica, the full-time teacher for the Mimbres School located at UNMCH. She guizzed him on multiplication tables and encouraged him to stay in school. Reflecting on her visits, Jesus said, "I wasn't interested in attending the school at the hospital, thought I wouldn't like it, and that it would be horrible."

But Jesus' grandpa insisted, so he registered for the Mimbres School. "Within a day or two of working with Monica, I started to feel really comfortable with her," Jesus says, "I could share what lessons I knew and didn't know. Working one-on-one with her helped me focus, and I can tell I've learned a lot in the seven months I've been enrolled in the hospital's school program. Monica discovered what can motivate me to do schoolwork, and she helped me set a plan for my future - now I want to learn!"

"If not for this program, I honestly don't know where I'd be right now." said Jesus. With his full English and History credits for 2019 now completed through Mimbres, he is completing other coursework and will

SLFCU Gives Back to Our Most Vulnerable Neighbors

SLFCU has committed to giving a total of \$45,000 in 2020 to ten organizations in New Mexico and Livermore, California who are helping take care of those in need during the COVID-19 pandemic.

One of those non-profit organizations is The Barrett Foundation, which provides shelter and safe housing for women and children experiencing homelessness or domestic violence.

The Barrett Foundation is working hard to keep the families they serve as safe as possible during this pandemic. According to Interim Executive Director Melissa Kaminsky, their clients are facing many obstacles during the pandemic. "Because we offer a community living environment, we have had to enforce limited contact for the women and children receiving our services," says Melissa. "The staff and those living at the Barrett House have embraced their "new normal"

of living together 24/7, and are striving to maintain a healthy living space."

Melissa adds, "Everyone in the community is working together to clean, cook, and keep a positive and peaceful environment. This has made everyone feel really close. It's times like this that truly make our communities strong. We are so grateful for the grant from SLFCU; it will really help."

SLFCU members can also help this worthy organization. The need is great for cleaning supplies, including paper towels and Clorox wipes, and most of all, disposable face masks to help keep everyone safe while in close distances, says Melissa. They can also accept kitchenware, toilet paper, disposable paper goods, and fresh foods such as fruits and vegetables.
